Re: Freedom of Information Act Request

Alerting Israel of Imminent Invasion before 10/7/2023

Pursuant to FOIA please provide the following requested documents. We request you create 2 sets due to the sensitivity of the material.

We request one set for us, the public and Israeli media (sanitized) and one unsanitized set to be delivered directly to the Hon. Moshe Drori, Head of Israel' Committee for the Investigation of use of Spyware and interceptive devices ("Roglot"), as follows:

1. For the period between June 1, 2023 and October 10, 2023, any message intercepted by the USA forces, military and intelligence by and between Hamas leaders and members of the Israeli security forces including IDF, SHABAK, MOSSAD AMAN etc., where the words "invasion into Israel, "escalation of aggression on Israel", "surprise attack on Israel" were exchanged or discussed. This request excludes ordinary conversations such as cooperation on infrastructure, equipment, food or money for governmental operations in Gaza. Specify the content, the date of the intercepted message and the name of the speakers or communicators.

2. For the same period as above, and the same scope of messages, identify messages intercepted between leaders of Hamas in Gaza and individuals in Israel whom you identified and protestors against the current Israeli Government.
3. For the same period as above, and the same scope of messages, identify any message that the USA has red flagged as suspicious, extraordinarily exceptional, and identify the date, time and name of the Israeli official whom the USA alerted.
4. For the same period as above, and the same scope of messages, identify any message intercepted between one particular member of the Shabak (or other secret agency), Mr. **Uri Windman**, and leaders of Hamas (such as but not limited to Sinwar, Deff and their subordinates). Identify the date, time, method of communication, names of speakers or communicators and the content of that message.
5. For the same period as above, and the same scope of messages, identify any messages that were brought by the USA to the attention of Mossad chief, Mr. **Ronen Bar**, and Mr. **Aharon Haliwa**, IDF Intel Unit (Aman) including intercepted information from Hamas conversations, AND USA's own forecasts or assessments that the situation with Hamas is escalating towards an invasion, and or that Hamas is preparing to launch an attack.
6. For the same period as above, and the same scope of messages, identify any messages communicating from USA to Israeli counterparts in security and intelligence that reliance on SHABI (the Shabak AI Robot) may be dangerous.

We are not interested in any names of USA officials whatsoever. However, we are interested in the names and titled of the Israelis who may have been negligent or reckless in assessing the imminent danger.

Please exempt us from any fees associated with this request as it is made for benefit of the public in Israel, and the undersigned is a USA credentialed press reporter.
