The revised Shalev affidavit is attached. K&S sent us a "clean" copy, so we ran a redline comparison to highlight the changes. A few notes:

- 1. The sentences highlighted in green reflect changes made by NSO in response to the feedback we relayed from you. (I added the green highlighting to make these parts easier to find.)
- 2. Paragraph 8 (in the clean copy) asserts that MoD requires NSO's end-users to sign end-use certificates. We relayed your comments on this paragraph, but NSO's lawyers responded that they confirmed this practice with respect to each NSO license. Please let us know if this paragraph is correct as written, and whether you would like us to relay further feedback.
- 3. As John mentioned earlier, NSO would like to attach a copy of the ECL, but their lawyers have heard through other channels (not from us) that the Government of Israel does not want NSO to attach a copy of the law. (This point is highlighted in yellow in paragraph 5.) Please let us know the Government's position so that we can clarify this issue with K&S.

Thanks for your guidance yesterday on the Shalev affidavit.

We relayed all of your comments to Rod Rosenstein and Sumon Dantiki last night. Most of the our comments were similar to the comments we had made on the same sentences in the MTD the previous day, so they were not surprised, and we got little push back.

In several cases, they did propose alternative language for us. We said in a few cases that their suggested revisions were consistent with our understanding of the facts, but that we could not "approve" revisions because we do not have the expertise. We said that the GoI would certainly be willing to review a revised draft if there is time.

We also asked whether Joe Akrotirianakis will request an extension. Rod said that Cooley has not agreed to an extension (no surprise!), and that Joe is therefore not inclined to ask the court to grant an extension. As of now, K&S plans to file everything tomorrow.
