Thanks Marlene:

I've also been surprised that we have not seen a draft affidavit for Shalev, since K&S said on Friday that it is their top priority. I assume they are still working on it. They know you need to review it and may object to certain statements. I will check.

We have been reviewing the MTD. It has improved, although it would still rely on some unusual statements in the MoD letter.

Hi John and Reeves

Hope you are all doing well in your respective states...

In addition to the updated MTD, we sent last night (which incorporated some of our comments about not putting Israel in the "front") - we were sent a letter instead of an affidavit (attached) for MOD to consider. Ram/MOD is reviewing it but we have not yet formulated position on whether we think is

wise to give in a letter of this nature (or adjusted) and would appreciate your thoughts as to letter, and how you think it could be helpful to the company to get the case dismissed, and what is the potential exposure for us and if there are ways or alternate means to relay this information in a different format (we are looking at some other options on this).

We also would like to see the affidavit of Shalev – and any other documents they are planning on filing (affidavits/motions..) instead of relaying our comments piecemeal so that we can see the full picture. Can you get that information from Rod?

We have an internal call to discuss our comments to the drafts at 16pm Israel time, and would like to have conference call this evening at 21:30pm if that works for you. We would also like you to put together your comments to the drafts (as to what is problematic from our perspective) and we will add ours – with a hope to get back to the company tomorrow with all the comments on this round.

If you can circulate the dial-in that would be helpful.
