It was good to talk with you all today. After our discussion, John and I considered the cloud issue further. If the server is located in the United States, we sense a real risk that Judge Hamilton could react negatively to efforts to remove information relevant to the lawsuit. She might expect, under those circumstances, that Israel would first intervene and seek the U.S. court's cooperation to limit the scope of discovery before taking unilateral action within the United States against third parties. Thus, we should consider carefully the repercussions of extending the Israeli order to capture information (possibly) located in the United States, as that act could conceivably cross the line from protective self-help into perceived interference with the US litigation.

Please let us know if you have any questions on this issue or others that we discussed today.
